

# General Conditions of Use (GCU)

## 1. Purpose

The purpose of these General Conditions of Use (hereinafter "GCU") is to define the rules for using the **IMIN EVENT application** , published by DOANDGO, accessible on mobile via the Apple and Android platforms.

The Application allows users to organize private activities (sports, cinema, outings, etc.) with friends, in a simple and friendly manner.

## 2. Acceptance of the T&Cs

By accessing the application, the user unreservedly accepts these T&Cs. In the event of refusal, the user must stop using the application.

---

## 3. Access to the application

Access to the application is via a **phone number authentication system** . No first or last name or email address is required.

A nickname is automatically generated and an optional avatar can be added.

---

## 4. Expected user behavior

The application is based on social interactions between friends. Each user agrees to:

- Create only **real events** , in which he **intends to participate himself**
  - **Respect the people invited** in the titles or descriptions
  - **Do not post content that is insulting, vulgar, defamatory, discriminatory, hateful, obscene, sexually explicit or illegal**
  - Do not encourage dangerous behavior, contrary to the law or morality
  - Do not create fake events for the purpose of harm, misleading, or spamming

## 5. Moderation and sanctions

The Application team reserves the right to:

- **Moderate any non-compliant content**
- **Delete an event** or group that does not comply with these T&Cs
- **Temporarily or permanently suspend a user's access** , particularly in the event of:
  - Repeated reports
  - Creation of false or inappropriate events
  - Disrespectful behavior towards other users

Moderation can be **manual or automatic** , without the need for prior justification.

---

## 6. User Responsibility

Each user is **solely responsible** for the content they publish, the events they create, and their interactions with other members.

The Publisher cannot be held responsible under any circumstances:

- Consequences of a poorly organized or canceled event
  - Inappropriate behavior of a participant
  - Fraudulent or abusive use of the application by a third party
- 

## 7. Intellectual Property

All elements of the application (text, graphics, logo, interface, code, etc.) are the exclusive property of the Publisher. Any unauthorized reproduction is prohibited.

## 8. Account Deletion

## 9. Modification of the T&Cs

The Publisher reserves the right to modify these Terms of Use at any time. Users will be notified of any updates via the application. Continued use of the application constitutes acceptance of the new terms.

## 10. Applicable law

These T&Cs are subject to **French law** . In the event of a dispute, an attempt at amicable resolution will be prioritized. Failing this, the French courts will have jurisdiction.
